- 1. That the provision of the D.S.E.A, 1973 and the rules framed thereunder shall be observed by the society.
- That the Management of the School will fulfil all the conditions laid down under Rule 50 mg and provide all the facilities given in Rule 51 of DSEA, 1973 to the Institution.
- That the Management of the School will get the scheme of management approved from the department immediately.

- That the Management of the School will not ask for grant-in-aid from the Department.
- That the school will not run for the profit of any individual association or group of persons. 6.
- That in case at any time of Management of the School is unable to run the society, moveable and non-moveable property of the school will be transferred in the name name of the Director of Education, Delhi.
- That the Management of the School will apply for grant of recognition of the school under DSEA mit and Rules, 1973 separately and recognition will not be granted unless statutory provision of Sec.4(i) (a\_f) read with Rules 50 and 51 are fulfilled.
- 9. That all the Recognition classes shall be run at one place only.

- 10. That the Nanagement of the School will obtain 1 and from D.D.A in the name of the society.
- Nodel School, Budh Vihar, Delhi- 110041 and suitable funds will be made available for the construction of suitable building on the land allotted to the society as declared, as per the specifications of the Department within a period of 3 years and adequate and sufficient accommodation 12 sq.f. per student shall be provided for class-room. The normal size of a class-room is 24'x20'. No other activities other than education shall be run.

If Recognition for the proposed school is not sought after fulfilling all the above conditions within the period of 3 years, this permission to open a new school shall be treated as cancelled.
